Asociacion Conservacionista de Monteverde (ACM as it's initials in spanish), with legal certificate 3-002-075864-11, civil organization, for charity, declared of Public Utility for the interests of the State according to decree 33632-J.

Has as main mission "conserve, preserve and rehabilitate tropical ecosystems and their biodiversity". At the moment the ACM has managed to conform the greater private reserve in Costa Rica: The Eternal Forest of the Children (BEN, Bosque Eterno de los Niños, as it's initials in spanish). This has been possible thanks to the aid of children, adults, schools and organizations around the world (more than 44 countries). The BEN is part of the Reserve of the Biosphere Water and Peace and was declared therefore the 18 of September, 2007 by UNESCO.

Also the ACM is charter member of the Costa Rican Network of Private Reserves and member of the World-wide Union for the Nature. The ACM as an organization who dedicates to the protection and conservation of the natural resources for the present and future generations works with local organizations in the development of the communities, with which the implementation of different activities is facilitated and isolated efforts are not duplicated, on the contrary consensus and alliance to the benefit of all are realised in; therefore one of the organizations with whom we worked altogether is with the Project Asis.

This document certifies that, Project Asis has supported us in activities of Environmental Education (Tours of field with students, meetings, works with volunteers), having as a goal the preservation and Protection of the natural resources, as well as coordinating voluntary works in the BEN. Also, the Project You Asis has a Center of Rescue where it receives wild animal that are given by the Rangers of the ACM, these animal have been confiscated to hunters who have them in captive inadequate conditions to live.
